Minutes from the last meeting of 7 January 2010 were read by Michael Klein. Jim Kelly made a motion to accept the minutes as read, seconded by Fred Murphy and carried.

Treasurers Report was presented by Treasurer Vern Quast. The ending balance from 7 January 2010 was \$2,994.08. The current balance \$10,839.14. The profit of \$3,406.85 from the first Fish Dinner to be shared equally between HFH and St. Vincent de Paul Society has not been distributed and is included in the balance. The expenses and profits from the first 3 Fish Dinners are included in the balance. Total distributions of \$3,500.00 have been made to Dave Delahoussaye for the Men's Club commitment to the Confessional Project. Vern Quast said he will authorize Ellen to distribute \$1,703.42 each to HFH and St. Vincent de Paul leaving a balance of \$7,432.29.

Fred Murphy made a motion to accept the Treasurers Report seconded by Joe Colello and carried.

Chick Huettel reported the Confessional Project is completed and was blessed by Father Tom on Saturday 13 February at the 4:00 pm Vigil Mass.

Tom O'Hare reported on the replacement of the St. Rita sign on Moll Drive and Hwy. 98 using 8 inch high black reflective letters as requested on a white background is now estimated at \$250.00 and requested an increase in the budget of \$200.00 previously approved for the sign. Chick Huettel made a motion to approve an increase in budget to \$250.00, seconded by Ed Carone and carried. Tom O'Hare also reported he will verify the Easter Mass time schedule and complete the Easter Mass Sign.
